I agree to hold harmless the Auctioneer and his representatives as well as the auction yard against any claims of the nature referred to in this agreement or loss, theft, or damage of any merchandise. I guarantee delivery and agree to pay 15% COMMISSION based on the Auctioneer's valuation on item(s) sold prior to, or withdrawn from the auction as well as any item(s) brought onto Auction Premises and sold "Private Treaty." Unless other arrangements have been made any unsold items are to be removed from auction site within 1-week of auction by the Seller or additional handling and storage fees may apply. Any items left past 30-days without prior agreement will be considered abandoned and may be sold without notice.



All consigned items must have entrance fee (per lot) paid in advance prior to advertising and lot/item photos (up to 10 per lot), videos (1 per lot) and descriptions are the sole responsibility of the Seller to submit to the auction company 5 business days prior to start of auction.
